Scope Rulings & Anticircumvention

Determinations:

- Commerce found that the refrigerator shelves imported by Whirlpool are "finished merchandise" and thus exempt from antidumping and countervailing duties on aluminum extrusions from China.

- Commerce found that empty cylinders marked "DOT-39" that are imported for filling with refrigerants are not subject to antidumping and countervailing duties on high-pressure steel cylinders from China in its scope ruling issued in late July.

- Unprinted magnetic label holders imported by Tatco are subject to antidumping and countervailing duties on raw flexible magnets from China (A-570-922/C-570-923), the Commerce Department said in a scope ruling issued Aug. 23. The non-magnetic components of the magnet holders are not exempt from the AD/CV duty orders. On the other hand, magnetic label holders printed with a zebra pattern are exempt from AD/CV duties, even though magnets with printed with "stripes" are covered.

U.S. BUREAU OF CUSTOMS AND BORDER PROTECTION

- On August 14, 2017 - CBP found Eastern Trading NY “engaged in evasion” of antidumping duties on steel wire garment hangers from China, the agency said its Aug. 14. The decision marks the first publicly released final determination resulting from an investigation under CBP’s Enforce and Protect Act (EAPA) evasion enforcement processes. CBP announced late last year that it was investigating Eastern Trading NY following

allegations submitted by M&B Metal
and

imposed cash deposit requirements after finding a “reasonable suspicion” of evasion.

COURT OF INTERNATIONAL TRADE SUMMARY OF OPINIONS

- [Slip Op 17-93:](#)
The CIT sustained the ITC final affirmative determination in the original investigation on certain passenger vehicle and light truck tires from China.
- [Slip Op 17-95:](#)
The CIT affirmed Commerce final results of review of the order on narrow woven ribbons from Taiwan.
- [Slip Op 17-100:](#)
The Court sustained the final results of redetermination upon remand of the 8th administrative review of the AD order on frozen warmwater shrimp from Vietnam. The key issues involved the selection of certain surrogate values in the Department’s underlying analysis.
- [Slip Op17-102:](#)
The CIT reaffirmed the right of importers to use “tariff engineering” to import goods at lower duty rates. The importer had added stripped-down seats to a Ford cargo van and removed the seats immediately after importation to obtain a lower duty rate applicable to passenger vehicles which is a legitimate use of tariff engineering according to the CIT decision.

The court sustained Commerce’s remand in the 2011-2011 administrative review of the antidumping duty order on ball bearings and parts thereof from the U.K. The primary issue in the case was whether Commerce had the authority to reinstate reviews that were halted upon the revocation of the original order and the determination based upon adverse facts available were supported by record evidence.

The CIT upheld Commerce’s scope ruling that “hybrid” solar panels are subject to antidumping and countervailing duties on solar cells from China. The court agreed with the agency’s ruling that the addition of “thin film” to a panel’s crystalline silicon substrate does not exempt the importers solar cells from AD and CVD duties. However, an important note was the court directed Commerce to re-issue its liquidation instructions as the court found that Commerce had improperly ordered CBP to suspend liquidation prior to start date of the scope inquiry.

COURT OF APPEALS FOR THE FEDERAL CIRCUIT SUMMARY OF OPINIONS

The Court of Appeals for the Federal Circuit upheld the CIT’s decision upholding Commerce’s decision to apply the PRC-wide rate of 82.12% on imports of diamond sawblades from China. The primary issue was whether or not the plaintiff had sufficiently demonstrated its independence from state control in order to be entitled to a separate rate.
